Disregard of the rules and policies established by the management of Redwood Swim Club; or, an action or behavior by a member that threatens the health or safety of such member, other members, guests, staff or visitors; or, the use by a member of the grounds, facilities or equipment for purposes or in a manner other than for which they are designed; or, the use of the grounds, facilities, or equipment at a time when Redwood Swim Club is not open for regular business are among possible causes for membership to be suspended or revoked.

Benefits or privileges of membership shall not be assignable or transferable, except with written permission from dkRSC LLC.

Management assumes no responsibility for theft of or damage to personal property.
